TOWN OF TULLY January 14, 2015

Parks and Recreation

Jayne Morse reported on the following activities:

- Basketball programs are running very well
- The parks and rec board has decided to move the date of the Moo Run to the Community Fair days in September. The run will take place on the morning of September 12th and will follow the same route as the Turkey Trot. More info to follow.

 The ice harvest will be held on February 21st this year

Supervisor Lund, as part of the Parks & Rec report, announced that he is requesting \$50,000 for refurbishment of the walking trail with the help of Senator Valesky's office. Some discussion followed.

John Herold gave a brief report on highway activities including:

- ♣ We've had a few breakdowns including on December 10th when we had 26 inches of snow fall
- We're still well within budget
- Used guite a bit of material considering the amount of snowfall we've had, but we'll have plenty to finish out the season
- Final figure for Fall cleanup day was \$4,708.24; the amount of money we received for steel was down from past years
- John expressed concern about the highway building since it's going to need some repairs and would like to see the grant money soon. Brief discussion followed.
- 🖶 John also advised the board he needs the resolution approved for the highway maintenance permit

There was also a question by a board member regarding the beaver problem in Tully and Preble. Brief discussion followed.

RESOLUTION 4-2015

Captain Bryan Ramsay reported on ambulance activities as follows:

- ♣ 573 calls for the year plus 163 fire calls for a total of 736 calls for the year which is an all-time record for the past 12 years
- Had to take the A-1 ambulance in for repair; oil leak in the turbo; D & W Diesel covered it under warranty so no cost to us
- In the process of putting together specs for the new ambulance to go out for bid; just in the early planning stages

Mr. Chartrand explained that a permissive referendum will be necessary in order to spend the money that's in the reserve. That's subject to a 30-day wait period and then a 20-day estoppel period. You cannot order the ambulance until that period is up. So you can put it out for bid and start the permissive referendum to purchase the ambulance at that point. Discussion followed.

Bryan also explained that he had been notified that there is a patient with an artificial heart living in our district now. So there is online training for paramedics and EMTs, which Captain Ramsay has mandated for our crews, basically teaching them how to deal with someone who has an artificial heart during a possible medical emergency. Discussion followed.

Fire

Fire Commissioner Ed Wortley Jr. advised that all chiefs are remaining the same. We will be opening up the bids for the truck and the air packs at next month's meeting.

Floor

John McMahon thanked the town clerk for generating the building permit report. Secondly, John referred to the organizational resolutions, particularly the village members of the joint planning board and asked about the question marks next to their names. Some discussion followed.

Legal

Mr. Lund discussed the IMA with family services and suggested a motion to approve.
