Financial Report

Tom Chartrand started off with receipts and disbursements for the month of March including court fines which Tom reported are "at budget which is really good news"; Village of Tully forwarded the DASNY grant monies to the town, \$66,893.57; on the highway fund, we did receive the Tully Joint Fire District snow and ice removal funds for the private roads; trust and agency numbers quite large because there were three payrolls for highway and ambulance; ambulance recoveries, good month, almost \$10,000, and Pompey Hill Fire District Medicar service funding returned, plus a training reimbursement. On the expense side, pretty quiet other than payrolls which included overtime.

Aurelia Pellettiere, town tax collector, addressed the board this evening regarding the proposed county tax program. All tax collectors and receivers in Onondaga County were invited to attend a meeting earlier today with Don Weber, Director of Finance, who introduced this new program. The plan is to test the new program starting in May in several villages. It's a web-based program developed by an outside vendor for the county. Going with the new program will save the town several thousand dollars a year. Brief discussion followed with questions by board members and some input from Tom Chartrand who had some knowledge of the new program as well.

Parks & Recreation

Ryan Dando reported this evening on Parks & Rec activities:

- Registrations for Spring programs, baseball and softball, are open. 130 children have already registered.
- The Moo Run has been scheduled for June 9th.
- The town clerk sent an email today regarding the DEC wanting to do some deep water testing on Green Lake and looking for permission from the town. Brief discussion followed with questions and comments by board members who were in agreement to go ahead and have the DEC do their testing.
- The well is not done yet and have not received a bill yet.
- Bath house opening should be after April 30th

Highway

John Herold reported on the following:

- Crew was out plowing 19 times in March; 6 times in April so far
- Have had some truck repairs
- Started sweeping
- Making preparations for summer work
- The county is still using the garage
- Earth Day will be April 21st and 22nd this year; we will be taking drop-offs on Saturday at the garage from 8 till noon
- Spring Cleanup Day is May 12th
- We're waiting for some good weather to start work on the walking path; machines are reserved; the path should be about 5 foot wide
- We're going to be getting some money for extreme winter recovery and also for the PAVE NY program

Ambulance

Captain Bryan Ramsay reported on the following:

• EMS calls for March – 38; up on call volume for the first quarter of the year with 116 calls and for the same period last year we only had 90.

- Overtime costs continue to be a problem
- Also asked the County personnel to advertise for another paramedic test to increase the part-time roster
- Daytime response on fire calls still a concern due to low staffing during the daytime hours
- 1999 surplus ambulance we put on Auction Internationals, the bid is up to \$1525 as of tonight so that's good news
- It's been in the news that there's been an increase in heroin use in our region; in addition, there's also a problem with marijuana laced with rat poison. Brief discussion.

Fire

Ed Wortley reported that they're having the same problem as the ambulance, not enough volunteers during the day.

Floor

Councilor Speziale asked about train station funding. Supervisor Lund responded that he still needed to meet with Nancy Chawgo on that. He also reported that we do give the historical society \$5,000 a year.

Councilor Speziale also reported that it was discussed at the village meeting last week if the joint planning board has an application before them that involves village property, the village attorney should have a copy of the application so that all are aware of what's going on. Lengthy discussion followed.
