- 2.6 minutes response time which is lower for this past year
- ❖ Hour and eleven minutes for an entire call, on the average
- University Hospital, Crouse and St Joseph's primary transport centers
- 29% of the calls are in the town; 23% of the calls are in the village; remainder are in the other two areas we contract with
- ❖ New employee to start January 28<sup>th</sup>
- ❖ The annual report will be published in its entirety in *The Tully News*

### Floor

No comments from the floor this evening.

### Legal

Supervisor Lund started the discussion about the Lowell property on Green Lake. Mr. Primo explained that it was deeded to the town by Stan Lowell, who retained life use. Stan Lowell passed away on 11/2/12, and his wife has one year to vacate the premises. His wife does not live there, but their son Damon does, and may want an extension to live there beyond the year. Mr. Primo explained that it's clear from the deed that the wife, no one else, has until November 2013 to vacate the premises. It was suggested that a letter be sent to Mrs. Lowell and/or their son regarding the status of the premises. Mr. Lund will obtain mailing addresses and Mr. Primo will draft a letter to same.

The next legal matter for discussion this evening is the hydraulic fracturing. Mr. Primo explained the pros and cons of special permitting versus an outright ban. Mr. Lund spoke about the special use permit controlling traffic, etc. Resident John McMahon spoke in favor of an outright ban and encouraged the board to seriously consider that option. Further discussion ensued.
