# **Parks & Recreation**

Sarah Panzarella reported on parks & rec activities:

- Bathrooms at the pavilion are open

- Martha Boulay's cleaning service has been contacted to start cleaning the bathrooms
- Green Lake registration for Tully residents is now open; our numbers should work out including the other towns (Lafayette, Fabius & Pompey)
- The Moo Run is June 17<sup>th</sup>. It's in honor of Jim Paccia who is retiring. We're going to do it here on our cross-country course and invite alumni.

#### Fire

Fire Commissioner Ed Wortley was present this evening and reported that Boralex, a renewable energy company, will be coming to the fire department next week. Brief discussion followed.

# **Public input from the Floor**

William Lund, a resident, and speaking as a taxpayer, expressed concerns about the highway department losing half its workforce. Brief discussion followed.

Councilor Snavlin asked about the progress on the Rt.11a Water District. Mr. Masters explained that Barton and Loguidice, the engineering firm, needs easements to begin the construction. And since the land is being transferred from Honeywell to the Onondaga Nation, we need them to agree to those easements.

#### Legal Update

Next, Mr. Masters announced that the board would need to review Part 2 of the EAF for the SEQR for the overlay district. The planning board had certain recommendations for the town board, so Supervisor Masters read through the questions and the answers. Afterwards came the following resolution:

# **Resolution 36-23**

The Town Board has reviewed the full resolution concerning the completion of Part 3 of the Environmental Assessment form and based upon the reasons set forth in this resolution and the Town Board's review of the reasonably anticipated areas of environmental concern related to the proposed creation of the Overlay District, the criteria for determining significance in the SEQRA regulations, and the findings and conclusions stated herein, the Town Board finds that the creation of the Overlay District will not cause a significant adverse environmental impact and, therefore, an environmental impact statement need not be required to be prepared for this action.

The Town Board authorizes Supervisor Masters to execute part 3 of the EAF indicating the issuance of a negative declaration, and to direct the Supervisor to file and provide notice of the negative declaration in accordance with the applicable provisions of law.

Call for a vote (Speziale, Snavlin, Masters, Goodwin) Ayes 4 Nays 0

#### **RESOLUTION 37-23**

WHEREAS, having fully considered the Application, the recommendations of the Tully Joint Planning Board, the recommendations of County Planning, comments from the public during the public hearing, and the requirements of the Overlay District Law, the Town Board hereby makes the following findings and determinations regarding the review decision relating to the creation of the proposed Overlay District:

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF TULLY, as follows:

- 1. The prior recitals are incorporated by reference.
- 2. The Application, to the extent practicable, preserves prime farm land because the future projects will not displace any active farm, include minimal excavation or permanent structures, and require decommissioning in accordance with the Town's solar law. Therefore, the Town Board finds the Overlay District will not have a significant effect on prime farm land in the Town.
- 3. Although the Overlay District will include the existing Potter North solar project as well as two proposed solar projects, the three combined facilities which are owned by affiliated entities will not have a specific effect on community character. The board finds that siting these three facilities by affiliated entities will minimize the footprint by eliminating internal setbacks, and based upon the natural screening caused by topography and vegetation, views of these facilities from area residences and other locations in the Town will be minimal to non-existent. For the same reason, siting solar facilities within the Overlay District will not impact scenic views which are important to the Town.
- 4. Because of the unique topography and lack of visual impacts at this location, the Town Board finds that other alternative parcels for siting the overlay district, coupled with the availability of a desirable location adjacent to an existing facility, are not available or feasible for this Applicant.
- 5. The Overlay District is not located in close proximity to any lake and is not within the watershed of the Town's Kettle Lakes.
- 6. For all the aforementioned reasons, the Application to establish the Overlay District is approved, and the Applicant may proceed with further proceedings relating to its Application for Tier 3 Solar Energy System permits, including further public hearings, and further review consistent with SEQRA.

The question of the adoption of the foregoing Resolution was put to a vote which resulted as follows:
