 Another good month; sent the plows out 9 times in November and 11 times so far in December

- No breakdowns, equipment is running well
- We've had some spare time, so we've been painting inside, replacing ceiling tiles
- The letter of intent on the truck will be going out this week
- The cell phones that were bought and paid for have been cancelled so we'll save \$70 a month on that
- There is a question on an employee, and I'd appreciate if we go into executive session to discuss that

Ambulance

Bryan reported on ambulance activities:

- EMS calls for November were 35
- The annual maintenance was completed on all our medical equipment which included the three AED's for the Town
- Ambulance 2, while on an emergency call this past Monday had a strong smell of diesel fuel in the patient compartment. We were unable to transport, so Cazenovia Area Volunteer Ambulance was called to the scene and transported the patient. A-2 was found to have a broken fuel valve which has since been repaired, and the unit is back in service.
- The Certified Emergency Vehicle Operator (CEVO-4) course will start tomorrow night and will continue next Thursday night. I am also teaching it for the day time training on Wednesday, December 20th.
- We received a large planter with flowers from a patient who was very thankful for the
 care we provided to her. The patient was having a major heart attack, and we were
 able to transmit the EKG directly to the cardiologist, give the appropriate medication and
 get her to the hospital and the cardiac catheter lab in a timely manner.
 The doctor stated, "The ambulance crew probably saved your life with the care they
 provided in the field." We don't always receive such a compliment from the hospital or
 doctor. And such a nice gesture from a patient was very much appreciated by the staff.

Fire - Open Position for Fire Commissioner

Councilor Masters explained that he and Chris Chapman were asked to form a committee and interview candidates for the position. The candidates were Art Reinhardt and Jeff Rothery. After completing their interviews, they agreed to recommend Jeff Rothery for the position of fire commissioner.
