Parks & Recreation

Ryan Dando reported on parks & rec activities:

- A lot of work was done on the town baseball/softball field, and we plan to continue in the Spring, hopefully for a baseball/softball rec season
- Ryan discussed with the rec board a possible Moo Run this year as well as summer camps and what they would look like; if they are not possible, they are trying to come up with some creative ideas; brief discussion ensued

Fire

Ed Wortley, Jr. reported that Gary Malone had been reappointed by the Village as Chairman of the commissioners, and Jeff Rothery was appointed as Co-chairman.

Floor

No input this evening.

Legal

Supervisor Masters informed the town board members on the progress regarding the Route 11a water district. Honeywell has agreed to fund \$2,000,000 to the water district. Our expectation is that the money will take care of the necessary upgrades and that eventually OCWA will maintain the district. Town attorney Bob DeMore commented that we need 50% of the property owners to go forward with the district. A meeting is scheduled for Tuesday evening for those residents. Brief discussion followed.
