**Financial Report**

Mr. Chartrand discussed the changes in the budget, final assessed values, including the SOTS budget for which Feher continues to be our trash collector. Tom discussed the Monthly Statement of Supervisor for September and reported on court fines; on the highway fund, we did receive the CHIPS funds and the PAVE NY funds; ambulance recoveries are still doing well. On the expense side, Tom discussed the Aldi settlement and the DASNY money for the park as well as the fact that there were three payrolls last month. **Parks and Recreation**

Ryan Dando reported on the following activities:

- ✚ The soccer program is winding down; over 150 kids are playing
- ✚ The rec board is making long range plans for improvements over the next few years.
- ✚ Rec basketball starts in November and goes through March

Continuing with Parks and Rec, Supervisor Lund discussed pursuing County grants for special projects including the walking trail. Brief discussion followed.

**Highway**

John Herold reviewed highway activities as follows:

- ✚ Good month
- ✚ Equipment holding up well
- ✚ New tires on the Gradall
- ✚ Done with private roads as far as repairing potholes
- ✚ Crew continuing with ditching
- ✚ Started putting equipment on for the winter months
- ✚ As of the 22<sup>nd</sup> of October, we close up the bathrooms
- ✚ Cleanup Day went well; seemed to be less traffic
- ✚ We're planning on having the roof replaced on the town hall in early November
- ✚ John discussed the contract for the purchase of the sander from Onondaga County

**Ambulance**

Captain Bryan Ramsay reported on the following:

- ✚ EMS calls for September totaled 50
- ✚ Ambulance 2 is going to Homer Iron Works for repair of the rear bumper
- ✚ Staff did their annual "Fill the Boot" on Saturday, Oct. 8<sup>th</sup> and collected \$3250 for Jerry's Kids
- ✚ Starting in January, I will be changing my shirt color from navy blue to white; it is felt that this makes the person in charge more visible on the scene
- ✚ We are continuing to teach CPR to different members of the community
- ✚ We have three additional members that have joined the Ambulance District
- ✚ It is my understanding that the Fire District has requested a review of the Intermunicipal Agreement between the Town and the Fire District as it pertains to the staff. Bryan expressed an interest in having further discussion on this topic.

**Fire**

Ed Wortley, Jr. spoke about the gym at the school being open to the community now and suggested that Ryan may have more information on that. Ryan did say he believes the gym is open from 4:30 to 7pm Monday through Friday and is staffed by volunteers. You do need CPR training to be a volunteer.

Next, Ed discussed the intermunicipal agreement between the town and fire district that Bryan had mentioned earlier and felt that it was meant to spell out the duties of each which were never made clear. Lengthy discussion followed. Supervisor Lund suggested we find the agreement and discuss it further.

**Floor**

John McMahon had questions on signage in the Town of Tully, particularly, signs he had seen posted for high speed internet. There was a brief discussion with input by Courtney Hills. **Legal**

Town Attorney Courtney Hills reported that we have an agreement with fiscal advisors who have helped us with our bonds over the years, and apparently the laws have changed regarding the way they have to disclose their fees. Because it's an amendment to an existing agreement, the Board has to approve it.
