**Financial Report**

Mr. Chartrand reviewed receipts and disbursements for the month of April 2013. Tom reported on justice court fines being close to budget; ambulance recoveries also close to budget. On the expense side, it was a quiet month.

Next, Tom spoke briefly about fiscal stress monitoring, a topic of discussion at the thirteenth annual town finance school which he had recently attended. He also advised the board that the town's investment policy, which still names Alliance Bank, should be updated to reflect the change to NBT Bank.

John Herold gave a brief report on highway department activities including:

- Sweeping and ditching

**Ambulance**

Bryan Ramsay gave a brief report on ambulance activities as follows:

- Call volume for April was 33 calls
- Drug calls are continuing to be an issue
- Working on renewal for state certification

**Tully Newspaper – Response to Committee Report**

There was a brief discussion regarding what should be printed in the Tully newsletter. Councilman John Masters, who was one of the town officials on the newsletter committee when it was first being considered back in 1996, spoke in favor of limiting it to official town business.

**Legal**

Town attorney Courtney Hills advised the town board that the local law extending the moratorium will be expiring July 5th, so a public hearing needs to be scheduled for next month.

Prior to the motion, John McMahon encouraged the board to consider enacting a law that would ban all gas and oil exploration, all industrial processes relating to hydrofracking.
